YOU HAVE MANY WAYS TO LEAVE A LEGACY

Legacy gifts help you meet your philanthropic goals and extend your generosity well into the future. By including a gift to the Alexandria Education Foundation in your financial planning, you can continue creating opportunities for our students while advancing your personal and financial goals. In addition, these gifts can provide you and your family with tax and income benefits.

Below are just a few ways you can meet your own financial goals and leave an educational legacy for generations of students to come.

IN YOUR WILL

A will or trust is often a reflection of what is most important in a person's life. A bequest specified in your will/trust can create opportunities for students without changing the way you live your life today. The official bequest language for the Alexandria Education Foundation is:

I hereby give, devise and bequeath to the Alexandria Education Foundation, EIN 84-2833851. ____ percent of my estate (or the sum of \$____; or ___ percent of the residue of my estate), to be used by this organization for its tax-exempt purposes (or to be used for whatever purposes the donor directs - an unrestricted designation giving the organization the greatest latitude).

If you plan to make a charitable gift by including AEF in your will/trust, please meet with your attorney to discuss and update your will or trust. Please also work with AEF staff to ensure that we will be able to use your gift as intended.



GIVE THROUGH LIFE INSURANCE

You could create more and better opportunities for kids with a gift of life insurance. Some of the most satisfying uses for life insurance policies are connected to charitable gifts that support your values. Gifts of life insurance allow you to make a significant contribution without affecting the way you live today.

Whether it's a life insurance policy you no longer need or a new policy you decide to purchase, naming AEF as the beneficiary could help meet your charitable goals. The versatility of life insurance makes revisiting its use a good idea.

MAKE A GIFT NOW FROM YOUR IRA

VIA QUALIFIED CHARITABLE DISTRIBUTIONS

The IRS allows IRA owners age 70 1/2 or over to give up to \$100,000 directly from their IRA to one or more qualified charities annually without paying federal income tax on such distributions. Only traditional IRAs are eligible but owners of other types of qualified plans may roll assets into a new IRA to allow them to make gifts if such a rollover is otherwise permitted. Donors should consult with their tax advisor before doing so. You can request a charitable rollover withdrawal form through the bank or company where your assets are held.

PLEASE LET US KNOW YOUR PLANS

It would be wonderful to know if you have included AEF in your will or as a beneficiary in your life insurance policy. This would provide AEF the opportunity to thank you for your generosity. If you prefer to remain anonymous, your gift will be kept completely confidential. At the same time though, recognition of your gift may inspire others to do the same. Whatever your preference, AEF will honor your wishes.
